PURUSHOTTEM, WHO WAS ONE OF THE DOCTORS AT PMH FROM THE BURN INTENSIVE CARE UNIT, WHO TREATED THE COMP, STATED TO AOS THAT THE COMP HAD SUFFERED SECOND DEGREE PARTIAL THICKNESS BURNS ON HIS LEGS AND SECOND DEGREE BURNS TO HIS RIGHT HAND.
